

Revolving Credit Facilities

Merchant Cash Advance If your clients customers' pay them via card machines, they may be able to find a lender to advance a cash sum based on their card sales. This is then repaid by a small percentage of each card transaction, meaning there are no fixed monthly repayments. If their sales drop, their repayments drop too.





